

TUNER EVOLUTION

Vendor/Sponsor Rules & Guidelines

PASSES

Passes (wristbands) for you and your staff will be given to you at load-in/check-in. They must be worn at all times once the event has started. No pass, no entry, no exceptions! We are not responsible for lost or stolen passes! If you lose any of yours, you will be charged the regular admission price for each replacement.

TABLE/CHAIR RENTALS

If you are renting any tables, your company must check them in and out at the Tuner Evolution Booth. You will be charged \$100 per table for any lost or damaged tables.

DESTRUCTION OF PROPERTY

You must show respect to the space provided and not make any modifications to the existing space. You are responsible for any damages done to the property.

SOUND LEVELS

You are responsible for keeping the noise level at a minimum as to not interfere with other competitors/exhibitors. If for any reason your booth is deemed disruptive or objectionable, you may be removed from the event.

NO REFUNDS

If for any reason, you fail to take possession of your booth space at the event, no refund will be given once payment has been received.

CIRCUMSTANCES BEYOND OUR CONTROL

Tuner Evolution will not be held responsible or liable for any damages caused by circumstances beyond our control such as weather, lockout, civil disobedience, and other forces of nature.

INSURANCE

All vendors/sponsors must secure their vehicles and property at all times. Tuner Evolution shall not be responsible for any loss and or damages to any of your property for any reason. You must follow all guidelines and security arrangements within the facility during load-in and the event itself. If you wish to insure your property, you must do so at your own expense in advance of the event.

COMPLIANCE WITH LAWS

Tuner Evolution shall have the power to enforce all terms, rules, regulations and any other stipulations necessary for the proper conduct of the event. Vendors/Sponsors must comply with local Police, Fire Department, and expo center laws, rules, and regulations. Failure to comply shall entitle Tuner Evolution to terminate its relationship with your company immediately.

PROMOTIONAL MATERIAL

You may hand out materials related to your business. Other promotional materials are not permitted for distribution unless authorized by Tuner Evolution.

OTHER GENERAL RULES

Absolutely NO burnouts will be permitted on the property! If so, you will lose all access and will be removed from the premises!

NO ALCOHOL MAY BE BROUGHT IN TO THE EVENT.

Food may be brought in by vendors/competitors before the event starts. If you bring in coolers/cooler bags they will be searched by security.

NO VEHICLES SHOULD BE MOVED, STARTED OR LEAVE THE PREMISES FOR ANY REASON UNTIL THE CONCLUSION OF THE EVENT!!
